

CUSTOMER PROTECTION - MANDATE

- 1) Customer represents that it is aware of BlowMouldingOnly being a means of publicity for owners and stockists of machinery, that BlowMouldingOnly is not the owner of the machines advertised on the Internet site, that any photograph or technical specification on the Internet site is supplied by the owner, and thus, acknowledges that BlowMouldingOnly shall not in all and any way be deemed liable for negotiation or sale of machinery advertised on the Internet site.
- 2) Whereas all negotiations all negotiations, after first contact, directly proceed with machinery owner, the Customer accepts and acknowledges that BlowMouldingOnly shall not in all and any way be held liable for correspondence/negotiation between seller and buyer.
- 3) The Customer accepts to take on the charge of verifying authenticity and accuracy of material and information (descriptions, product, photographs, videos, illustrations, prices, etc.) contained in the offers published on the Internet site and holds BlowMouldingOnly harmless from any liability concerning accuracy, reliability and completeness of said data.
- 4) The Customer indemnifies and holds BlowMouldingOnly harmless from any claim for damages arising from and caused by sale/purchase negotiations for machinery in relation to advertisements published on the Internet site.
- 5) The Customer assigns BlowMouldingOnly sole, irrevocable and exclusive mandate for the sale of machine (*identify machine*), at the minimum price of (*indicate amount*) euro gross of commission due for sale, for a period of 6 (six) months, automatically renewed for periods of the same duration unless notice of cancellation is received as of at least 30 days through fax to be sent to the following fax number: +39-0232066987.
- 6) The Customer accepts to pay BlowMouldingOnly, in case of sale, for a commission of (*indicate percentage*) of net value, with minimum commission of (*indicate amount*) euro. The commission shall be paid within 15 days from payment receipt. In case of failure to sell no commission shall be charged.
- 7) The Customer entitles, from now on, BlowMouldingOnly to purchase, on his own, machine identified at item 5), for the price as indicated in item thereof, net of accorded commission.
- 8) The Customer expressly acknowledges that, notwithstanding any dissimilar provision, any controversy that may arise between Customer thereof, and BlowMouldingOnly shall be exclusively settled in accordance with the Italian laws.
- 9) The Customer expressly acknowledges that, notwithstanding any dissimilar provision, any controversy that may arise between seller/buyer, and BlowMouldingOnly shall exclusively be under the jurisdiction of the Court of Milan.
